General In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

Inhalation If symptoms develop, move victim to fresh air. If symptoms persist, obtain medical attention. If breathing has stopped, trained personnel should administer CPR immediately.

Eyes Flush with cool water. Remove contact lenses, if applicable, and continue flushing for at least 15 minutes. Obtain medical attention.

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high puls pressure. Treat symptomatically.
